1. Medical Certificate: A medical certificate duly signed by a qualified MBBS/MD practitioner must be submitted.
2. Photographs: Two recent photographs of the parents and one photograph of the local guardian must be submitted.
3. Original Documents for Verification: Students must bring their original 12th class marksheet and original category certificate at the time of hostel admission for verification. If the category certificate is found to be incorrect or invalid, the hostel seat will be cancelled.
4. Affidavit: The prescribed language/format of the affidavit is available on the College website. The affidavit must be duly attested by a Notary Public. No affidavit in any other format or language will be accepted.
5. Presence of Parents: Parents must accompany the student at the time of hostel admission.
6. Commencement of Admission: The hostel admission process will commence w.e.f. 01 SEPT. to 10TH SEPT. 2026.

AFFIDAVIT

solemnly affirm and declare as under:

1. That I am the father/mother/legal guardian of Ms. _____, who is a bonafide student of _____ Course, Govt. College for Women, Gandhi Nagar, Jammu, and has applied for admission to the College Girls' Hostel.
2. That I undertake that my daughter/ward shall strictly abide by all the rules, regulations, instructions and orders issued by the College/Hostel Authorities from time to time.
3. That my daughter/ward shall not leave the Hostel premises without obtaining prior written permission from the Hostel Warden/College Authorities. Any violation shall invite disciplinary action, including suspension or expulsion from the Hostel.
4. That my daughter/ward shall maintain proper discipline, decent behaviour and respect towards the Hostel Warden, Hostel Committee and Hostel staff, fellow residents and all Hostel property. She shall not indulge in ragging, bullying, violence, harassment, abusive behaviour or any act prejudicial to the discipline and reputation of the College/Hostel.
5. That my daughter shall not permit any outsider or unauthorized person to enter or stay in the Hostel room under any circumstances. Violation of this condition shall make her liable for strict disciplinary action.
6. That my daughter is medically fit and does not suffer from any contagious disease or any illness requiring constant parental care or special medical attention. Any change in her medical condition shall be immediately intimated to the Hostel Authorities.
7. That the College/Hostel Authorities shall not be responsible for any mishap, accident or incident occurring outside the College/Hostel premises. The parents/guardians shall be solely responsible for the safety and conduct of the student outside the campus.
8. That I fully understand and undertake that the Girls' Hostel follows a Zero-Tolerance Policy towards the consumption, possession, purchase, sale, distribution or use of alcohol, tobacco, cigarettes, e-cigarettes, narcotic drugs, intoxicating substances or any prohibited items, as well as involvement in any criminal, immoral, anti-social or unlawful activities.
